# SOCIAL OUTREACH REPORT

## **SOCIAL OUTREACH SUBCOMMITTEE REPORT 2021-2022**

The Social Outreach Subcommittee is the branch of N.A.P.S. that facilitates the alumni giving back to the school and its students. The purpose of this subcommittee is to assist the students who may not have adequate financial support. Through our vast network, financial, emotional, educational, psychological, social, and medical support and assistance was provided to not just the Naparima College community but the wider national community as well.

## 1. NAPS Podcast Episode 1- The Vaccination Drive

The first episode of the NAPS Podcast was hosted on the 23<sup>rd</sup> November, 2021 by Dr. Mitra Maharaj and Yadav Mohip with guests, Dr. Navi Muradali, Dr. Mark West, Dr. Roshni Bissoondatt and Dr. Reeta Moonessar. This podcast brought awareness to the public on the ongoing COVID-19 Pandemic and the benefits of being vaccinated against the virus. It was done just prior to our Vaccination Drive as to also encourage those who weren't vaccinated at the time to get their jab.

### 2. Vaccination Drive

Our Vaccination Drive was hosted on the 27<sup>th</sup> November 2021 at the Southern Academy for the Performing Arts. We partnered with the South-West Regional Health Authority (SWRHA) and successfully administered 363 vaccines. 306 of those were COVID-19 vaccines and 57 of those were flu shots. We also provided meals and refreshments for the staff at the Mass Vaccination Site on the day as an appreciation for their dedicated service throughout the pandemic.

## 3. Free Online Health Clinic

We partnered with Virtual Wellness Caribbean, The Supermarket Association of Trinidad and Tobago and SEWA TT to host the first ever Free Online Health Clinic. 587 patients were seen at the online clinic which ran for 15 days from 17<sup>th</sup> December to 31<sup>st</sup> December 2021. The clinic allowed the public to have a virtual consult with doctors, dietitians, counsellors, pharmacists, physiotherapists and much more.

## 4. Voucher Donation Drive

Vouchers were chosen, as this gives the recipient the freedom to select individually the items that will benefit their household the most as opposed to receiving a generic hamper with some items they may never use. 34 students were the beneficiaries of a \$300 voucher for books and stationery from Mohammed's Bookstore Associates Ltd, a \$500 voucher from the Debe and Cocoyea Supermarket and a \$250 voucher from Valini's Drug Mart. The vouchers were hand delivered to the homes of the students by members of the executive and the social outreach committee on the 16<sup>th</sup> April 2022.

## 5. Blood Donation Drive

One unit of blood donated can save up to three lives and this coupled with the severe nationwide shortage we partnered with the North- West Regional Health Authority to host a voluntary blood donation drive on the 14<sup>th</sup> May 2022. The mobile unit attached to the blood bank was utilized to facilitate these donations. We were able to collect 25 Units of blood which will be filtered into the public system and will be crucial to give someone a fighting chance. These units were collected from teachers, past students, friends, and family of the College.

## 6. Psycho Education/ Psychological Counselling

With the pandemic came a lack of social and physical interaction that is vital for the overall psychological development of teenage boys. In this light we have formed a team of psychiatrists, psychologists and other past students that are qualified and are willing to give lectures and seminars to the students on topics surrounding these issues. This team will also work hand in hand with the counsellor that is assigned to the school from the Ministry of Education to support students with any mental ill health issues.

## 7. Big Brother Program

The Big Brother Program was a significant part of the alumni but has been dormant for some time. We have been working on a structure and format for the program that is both feasible and

effective to the students that need it most. This program will soon be ready for roll out and will be one to look forward to in the future. It will encompass assistance to students not just financially but academically, socially, psychologically, spiritually and professionally where possible.

## **LEGAL REPORT**

### **LEGAL SUB COMMITTEE REPORT 2021-2022**

The Legal Subcommittee is the branch of the Naparima College Association of Past Student (N.A.P.S) that has been tasked with giving effect to the mandate of the Executive to bring the Constitution of N.A.P.S contemporary with the technological advances in current times. The Constitution was created and passed in the year 2009 and while ahead of its time then, did not contemplate the current state of society and of the Alumni.

The intention and directive given is to have the Constitution streamlined, bring it in line with the objectives of the Association, and with a significant emphasis being placed on inclusivity of the brotherhood of the Alumni.

The Legal Subcommittee duty also included assisting the Executive, the Association, Naparima College with any legal issues that may arise and require assistance.

It is to be noted that while the Constitution (in its present incarnation) does not provide for Subcommittees within the Association, towards the aim of making the Association more inclusive, various Subcommittees were formed, and as will be shown below, amendments are being proposed to have these various Subcommittees included in the Constitution.

## MEMBERS OF THE LEGAL SUBCOMMITTEE

The members of the Legal Subcommittee consisted of both legal minds, members of the Alumni without legal background, members of past and present Executives and members of the Alumni residing abroad. Meetings were facilitated via the Zoom platform and the membership comprised of Mr. Joel Simmons (President N.A.P.S), Mr. Damian Baboolal (Secretary N.A.P.S), Mr. Ahmed Saidwan (Trustee N.A.P.S), Mr. Ramkishore Maharaj (Executive Member N.A.P.S), Mr. Kent Samlal (Executive Member N.A.P.S), Dr. Rajiv Jebodh, Mr. Michael Vialva, Mr. Keshav Bahadursingh, Mr. Michael Matthews, Mr. Amrit Garibdass, Dr. Emir Crowne, Mr. Hiran Rampersad, Mr. Rajiv Katwaroo and Dr. Kalicharan Ramnarine.

At the first meeting of the Legal Subcommittee, Mr. Kent Samlal was appointed as Chairman of the Legal Committee, Mr. Michael Vialva appointed as the Vice-Chairman, and Mr. Hiran Rampersad appointed as the Secretary.

## **LEGAL REPORT**

### **REVIEW OF THE CONSTITUTION**

The members of the Subcommittee reviewed the Constitution and in keeping with the mandate of the Executive, made various suggestions towards giving effect to that directive, namely:

- 1. The updating and recording of previous amendments made to the Constitution, duly ratified, such as the term of the Association being two (2) years (which was ratified) but recorded in the Constitution as being one (1) year;
- 2. The inclusion of various Subcommittees including (at this time) Legal, Social Outreach, Sports, Finance, Public Relations and Events. It is intended that Subcommittees be formed to facilitate foreign members of the Alumni and also a Women's Arm.
- 3. The inclusion of Voting procedures to be conducted at any Meeting so requiring such, including the formation of an Election Committee, the Method of Voting making allowance and provisions for foreign members of the Alumni and a Nomination procedure.
- 4. The inclusion of a membership form.

It is the intention of the Executive and the Legal Subcommittee to have these proposed amendments submitted to the Alumni for review and to be voted on and/or ratified at the Annual General Meeting scheduled for the 25th day of September 2022.

### **OTHER BUSINESS ARISING**

There are two (2) issues that this Committee has been asked to look at and advise the Executive and the Principal of Naparima College:

- I. Firstly, the Executive and in particular the Finance Committee has asked to look at whether the Association can be registered as a NGO and to advise the Executive on the pros and cons of same. This issue continues to be addressed by the Subcommittee and a report is to be provided to the Executive.
- II. Secondly the Principal, Mr. Ali has made the Executive aware that two (2) websites (attached as (a and b) are utilizing the College's name in selling items and would like advice on how this can be addressed.

### **SPORTS COMMITTEE REPORT 2021-2022**

Naparima College is synonymous for its academic excellence and its dominance in sports more specifically on the football field. Under the astute management of Percy Samlalsingh with the support of the past student's association the football program has achieved uncharted levels of consistent success over the last decade. With

secondary schools sporting activities finally reopening in September 2022 the Sports Committee is excited for the opportunity to serve and continue supporting the school's sporting programs under the guidance of Percy Samlalsingh and acting principal Roger Ali. Although our football program has been very successful on the field there is still room for improvement especially off the field of play. We would also wish to add more attention to detail and funding for other sporting activities. Many of the other sporting programs have the student talent and potential to be as successful as the football. Our ultimate goal is to help nurture and provide all the tools for our student athletes to be successful after leaving Naparima College.

After several meetings with the Mr. Ali and Mr. Samlalsingh the decision was made by Mr. Ali that the school would now take on the responsibility of sponsorship procurement for the football program specifically. The executive is still very much involved in supporting the football team but no longer overseeing the day-to-day operations like past times. Led by Andrew Bailey and Justin Ballack the sports committee has successfully completed several major projects in 2022.

## 1. Resurfacing of Lewis Street ground

The Covid\_19 pandemic forced the Lewis Street ground to be closed for almost 2 years. With restrictions on contact sports being lifted in 2022 much work was needed to get the facility up to training standards. In April of 2022 the Lewis Street ground underwent a resurfacing project that cost approximately \$25,000. The project entailed 25 loads of sand being spread across the entire surfaced and rolled.

## 2. Nicholas Pooran Sponsorship

On June 24th, 2022 West Indies Captain Nicholas Pooran visited the college and spoke to the students in the assembly. During Pooran's speech he pledged to sponsor the schools cricket team for the 2023 season both financially and with equipment. Since taking office in October of 2021 the executive made clear objectives to be more inclusive and have more alumni involvement. Nicholas Pooran was one of the past students the sports committee reached out to for support and without hesitation he agreed to assist.

## 3. Sponsorship Procured to install stadium seats at Lewis Street Ground

The sports committee was able to procure sponsorship from an alumni member of the school to outfit the Lewis Street pavilion with 200 plastic stadium seats for the VIP area. The project will cost approximately \$70,000 and is expected to be completed for the 2023 cricket season.

### 4. VEMCO Sponsorship

The sports committee was able to acquire sponsorship from VEMCO to supply the football team with Gatorade for the entire season. We hope to expand this relationship and have VEMCO as a sponsor for all other sporting programs.

## 5. Bridge repairs and Infrastructural work

The sports committee was able to do much needed repairs on the entrance bridge at the Lewis Street ground. Flash floods led to the foundation of the bridge being compromised, this issue has now been fixed. Plumbing repairs, painting and infrastructural work was also done in the dressing rooms and stands at Lewis Street. These projects costed approximately \$22,000.

## 6. Financial and Emotional support for Student Athletes

The sports committee has pledge to support members of the football team in acquiring football boots for the 2022 SSFL season. Players were given \$500 each to assist in acquiring a football boot of their choice. The committee also financially supports less fortunate players/ parents with traveling expenses. Meals have also been sponsored by the sports committee at practices during the preseason. Members of the sports committee are in communication with some of the parents of the student athletes and lending support in every way possible.

Alongside the events committee we plan to have more dynamic and vocal support at games. Supporter kits will be available for fans and pre- and post-game activities are planned on game days.

The Sports Committee is always open for new volunteers and new ideas, please feel free to reach out to us. We are always in need of donations whether it be financial or in kind and will be grateful for all support lent to us. We are looking forward to continuing our work into 2022/2023 and hope that we can reach out and continue to assist the Naparima College sports the best we can.

# **Executive Summary**


- Difficult FY 2022 opening cash position due to COVID related fundraising challenges and significant capital spend in previous fiscal year
- Therefore FY 22 financial priorities were:
  - 1. Ensuring every event was profitable
  - 2. Significantly reducing administrative expenses
  - 3. Pause on significant capital expenses
  - 4. Continued donations to the school
- All four objectives were achieved in the fiscal year and the focus in 2023 will be on rebuilding the operating cash + Trust fund to a target goal of \$1M dollars, while continuing to meet the needs of the College

## **Executive Summary – Historical Cash Trend**

- Historically low opening cash balance combined with Covid related restrictions meant we had to operate differently as an incoming Executive
- Combination of Cash on Hand + Trust Cash Reserves was down from \$1.2M to \$260K over previous two fiscal years



## **Balance Sheet & Cash Flow Review**

#### **Balance Sheet**

- Balance Sheet Cash of \$205K with PPE valued at just over \$1M
- No Payables due. Minor receivables / prepayments of \$17K owed
- Significant balance sheet liability carried over from prior fiscal year of \$1.1M. This was driven by use of funds liquated from Trust in the prior year.
- Focus on FY 23 to rebuild the Trust from ground zero and turn that liability on our books to an asset for the benefit of future generations

## Cash Flow Statement

- Cash Flow from Operations up from prior fiscal year by \$190K largely driven by strong profitability in current year period
- 90% reduction in capital spend vs prior year due to precarious incoming cash position and pandemic overhang. Freeze on capex instituted from Nov – August 22
- Net reduction of \$54K in cash at bank over the fiscal year vs prior year


## Conclusion

It was an established policy decision by the Association to contribute 10% of the surplus earned from events held into the Naps Charitable Foundation's Fund. The Trust Fund was terminated by the last Association in 2019 due to the Trustee no longer offering Trust Services. The Trust's funds were deposited into an RBC Bank Limited Account. An attempt was made to engage a new Trustee, however this did not materialise. The Association in November 2019 decided to transfer the funds into the Association's Operating/Chequing Account. This transfer was completed in October 2020. As such, there was no appropriation to this fund in the Financial Year 2022.
